#### **1.0 INTRODUCTION**

The Central Bank of Nigeria invites sealed bids from bidders for a project to implement a national baseline survey on financial literacy.

#### 2.0 SCOPE OF WORK

The following shall be included in the scope for the implementation of the National Baseline Survey :

- Collaborate on the development of a sampling approach that will be used for the National Survey. Estimated size of the Survey will be 11,500 Households in 1,150 Enumeration Areas across Nigeria
- Development of survey instruments that will be used in the National Survey
- Implementation of a Pilot phase of the Survey
- Implementation of the main survey
- Responsibility for all logistics issues including recruitment and training of the enumerators that will take part in the survey
- Data gathering and analysis
- Development of reports

#### **3.0 GENERAL REQUIREMENTS**
