- (iv) Certificate of Compliance issued by the National Pension Commission as evidence of fulfilling employer's obligation to employees with respect to pensions.
- (v) Evidence of payment of training contributions to ITF(Industrial Training Fund)
- (vi) Evidence of registration with FRC(Financial Reporting Council of Nigeria)
- (vii) Evidence of Accreditation with the respective vehicles manufacturers.

Others

- a. Corporate profile of the firm including CV of key personnel registered address, functional contract email address, GSM phone number(s), facsimile number(s).
- b. Audited accounts in the last three(3) years dully stamped by licensed Auditors.
- c. Verifiable evidence of similar jobs successfully executed in the past.
- d. Reference letter from a Bank stating the financial ability of the vendor to carry out such project.
