WHEN CONSENT IS REQUIRED

Consent (given by a statement or a clear, affirmative action) is required:

- when personal data is being collected initially from staff, stakeholders, third parties through the CBN Intranet (Banknet) or CBN Internet website
- before processing personal data
- before processing special categories of personal data/sensitive data
- from parents/guardian before the Bank can collect the personal data of a child
- before storing sensitive personal data
- before sharing stakeholders personal data with third parties

Please note: Oral consent is not yet allowed.

CONSENT WITHDRAWAL

A stakeholder can withdrawal his/her consent from:

- further collection of his/her personal data
- processing/further processing of his/her personal data
- further processing/further processing of his/her sensitive personal data
- not to continue storing his/her personal data
- not to continue storing his/her sensitive data
- not to continue to share personal data
- Also, parents/guardian can withdraw their earlier consent objecting to the processing of their children's personal data
