**REVIEW OF TERMINAL ALLOCATION TO PRE-SHIPMENT INSPECTION
AGENTS (PIAs) AND ALLOCATION OF PIAs TO MONITORING AND
EVALUATION AGENTS (MEAs)**

This is to notify All Authorized Dealers, Nigeria Customs Service, Nigerian Upstream Petroleum Regulatory Commission, Nigerian Midstream & Downstream Petroleum Regulatory Authority, Nigeria National Petroleum Corporation Limited, All Terminal Operators, All Oil & Gas Companies and the General Public of the Federal Government's review of the current allocation of Terminals to Pre-shipment Inspection Agents (PIAs) and the allocation to Monitoring and Evaluation Agents (MEAs) for the Crude Oil & Gas Sector.
