- (v) Evidence of payment of training contributions to ITF (Industrial Training Fund).
- (vi) Comprehensive company profile.
- (vii) Comprehensive company profile.
- (viii) Verifiable evidence of similar jobs successfully executed in the past.
- (x) Current Company's audited statement of accounts for the past 3 years, and duly stamped by a registered Auditor.
- (xi) Proposed method statement for the execution of the project.
